The Illinois Environmental Protection Agency (IEPA) has requested that Fermilab complete the 2012 Hazardous Waste Report, pursuant to the requirements under 35 *Illinois Administrative Code*, Part 725. IEPA provides a website, where you may obtain the .pdf files of the reporting forms/instructions and a downloadable software package for data entry:

If you are unable to access the reporting forms via the Internet, you may request a printed copy of the reporting forms by telephoning Hope Wright at (217) 785-2361. Ms. Wright may also be contacted regarding technical questions and completion of the report.

IEPA also requests in the enclosed letter that large-quantity hazardous waste generators pay a 2012 Large Quantity Generator Annual Fee of \$500. You do not need to pay this fee, since Fermilab is already paying \$500 in permit/inspection fees for its hazardous waste storage facility.

We will appreciate receiving confirmation of the completed electronic report in this office no later than February 15, 2013. If possible, please provide a hard copy at that time.

Dear Hazardous Waste Generator/Facility

You have been identified as being either a Large Quantity Generator or a Treatment/Storage/Disposal (TSD) Facility of hazardous waste, based on either your notification of hazardous waste activity for one or more months during the last calendar year or your most recent hazardous waste annual report. This may have been due to on-going generation, a remediation activity or clean-up, or another one-time event.

Illinois law mandates that all Large Quantity Generators must submit an annual hazardous waste report and a \$500 fee to the Illinois Environmental Protection Agency by March 1 of 2013. Treatment, storage, or disposal facilities must also submit a report; however, if they already pay a Permit and Inspection Fee they are not required to also pay the fee with the annual report.

The IEPA is distributing the forms via the Agency web site. You must download the forms and complete the report for the location identified, as described in the instructions, and submit the \$500 fee. *Please review the pdf instructions for clarification of several points, they are highlighted in the instruction document.*

If during 2012 you were not a large quantity generator or TSD facility for any month in the year, complete the Identification and Certification form, indicating your updated status; in that case the \$500 fee does not need to be submitted.

You may download the .pdf files of the reporting instructions/forms (refer to the file for changes made in the report) as well as a downloadable software package for entry. If you are *not* a large quantity generator, you may access the **Form IC only** without use of the electronic package, complete it on-line, Print, sign and submit to **update your status.**
